Voter Registration
 Applications for Voter Registration are located at the County Administrative Building, Room 306, all city halls, libraries, banks and all county fire stations. The fire stations are open seven days a week. The application may be completed at home, work, etc. There is no requirement for the application to be signed in the presence of a Deputy Registrar.

Voter Registration cards will be mailed from the office of the Secretary of State of Georgia.

IF YOU MOVE YOU MUST INFORM THE REGISTRAR'S OFFICE BY NOTING THE CHANGE ON THE BACK OF YOUR VOTER REGISTRATION CARD OR BY COMPLETING A CHANGE OF ADDRESS CARD.

Absentee Voting
 Applications for absentee ballots are available by calling the Board of Elections & Registration office or by going to the Sec. of State website, www.sos.state.ga.us/elections.

Absentee ballots may be cast by the voter in person at the Registrar's Office. Absentee ballots may be cast if the voter is ill, over 75 years of age, an election worker, observer of religious holiday, or required to be absent from his or her voting precinct all day on election day. For out-of-town students or disabled voters, a family member may request an absentee ballot.

Advance Voting
 Advance voting takes place in person at the Elections & Registration Office during the period of Monday through Friday of the week immediately preceding the date of a primary, general election, or runoff. Voters in this category cannot receive a ballot by mail.

Identification
 Voters must present proper identification to poll officers before they are allowed to vote in any election held in the state of Georgia.

All terms are for four years. The Chairman's salary is set at \$10,000 above the state-set sheriff's salary, plus automobile and up to \$3,000 in reimbursed expenses. Commissioners are paid \$5,674.21 plus Civil Service Cost of Living increases and \$1,200. in expenses.

The Board of Commissioners makes all policy and approves any contracts over \$12,500. Meetings are on the 1st and 3rd Tuesday of each month at 6:30 p.m. The Chairman has a vote but not a veto; his is a full-time job with responsibility for all operating and personnel decisions, including setting salaries within budget limitations.
